To All Members of the Northeastern Community:

As we begin Sexual Assault Awareness Month this April, I am writing to share the results of a series of assessments Northeastern conducted in the Fall of 2023. We launched our ninth campus Survey on Sexual and Gender-Based Harassment, invited students to share open-ended feedback anonymously about sexual violence prevention and response, and offered listening sessions for LGBTQIA+, BIPOC, and International students.

Thank you to the students who took the time to participate on behalf of the Northeastern community. We are grateful. These efforts help to assess the incidence and prevalence of sexual violence on campus, to understand the experiences of survivors and barriers to accessing resources, and to determine needs around prevention, response, and education for the community going forward.

Survey Results

The 2023-2024 survey was administered to a random, representative sample of full-time undergraduate, graduate, and law students on our Boston campus. Due to the sampling structure and sufficient participation rate (11%), the results are generalizable to our full-time Boston student body for the first time in the survey's history. While many survey questions mirror those from prior years, more were added or updated to comply with the new Massachusetts Campus Sexual Violence Act. Given the new questions and the use of a random sample of students, this data is not directly comparable to prior years. This data will serve as a baseline from which to compare future data.

<u>Key Findings</u>

- 17.9% of survey respondents reported experiencing sexual touching without their consent, and 6.8% indicated experiencing sexual penetration or oral sex without their consent since they have been a student at Northeastern.
- Of students who report experiencing sexual assault, 17.7% of respondents indicated this happened in the fall 2023 semester, 11.5% in the summer 2023 semester, and 14.6% in the spring 2022 semester. Research suggests that the first

three months of the fall semester are a higher risk time for sexual assault on university campuses, and these survey results align with national trends.

- A deeper analysis of our results suggests that rates of sexual assault are highest for undergraduate students, LGBTQ+ students, cisgender women, students with disabilities, and students indicating their financial situation was often or always stressful.
- Students who reported having experienced any form of sexual violence were asked additional follow-up questions aimed at better understanding the nature and context of their experiences. For example, we learned that a significant amount of non-consensual sexual contact involved the use of alcohol or drugs, also in line with national data. This information will help to inform more targeted prevention efforts.
- 18.6% of respondents reported having experienced someone sharing unwanted remarks, jokes, images, or advances of a sexual nature. Since they have been at Northeastern, 3.5% of survey respondents shared that someone who refused to believe or acknowledge their identity, referred to them with incorrect gender pronouns or name, and/or prevented them from using an appropriate gendersegregated space on campus or treated them worse or differently because of their sex, sexuality, gender identity, or gender expression.
- Of survey respondents who are or have been in an ongoing romantic or sexual relationship, 3.8% report having experienced physical violence inflicted by their partner, and 11.7% report having experienced emotionally or psychologically harmful behaviors from their partner since they've been a student at Northeastern.
- We collected data on what types of behaviors students have witnessed and how often they intervened. For example, 10.2% of respondents witnessed a Northeastern community member continuing to pursue someone sexually who seemed uncomfortable. Of those students, 79.6% intervened sometimes, most of the time, or every time. This data will inform Northeastern's bystander intervention program.
- 88.3% of respondents indicated that if someone were to report an incident of sexual violence on campus, the University would take the report seriously. A majority of students who experienced sexual violence and/or harassment who spoke to a confidential resource about what happened agreed or strongly agreed that the University would do its best to honor the request of a person making a report about how to go forward with the case.

• As in past years, we continue to see high levels of agreement that respondents feel safe on campus (96.4%) and feel they have a role in making Northeastern a safe and supportive community (98.1%).

Feedback Form Results

In addition to Northeastern's Survey on Sexual and Gender-Based Harassment, we offered all students on all campuses the opportunity to share open-ended feedback related to sexual violence prevention and services via an anonymous feedback form. One hundred thirty five students responded, including students from N.U.in, Boston, London, Oakland, Portland, Seattle, Silicon Valley, and Toronto. Students primarily shared feedback about their experiences with campus resources and reporting.

Graduate students highlighted the need for increased awareness and exposure to resource options related to sexual violence. This feedback is in line with survey data, which indicates that graduate students are less aware of campus resources and options related to sexual violence than undergraduate students are.

New Initiatives and Future Direction

Northeastern staff will continue to process the data collected through these assessments to determine new initiatives and next steps. We are particularly focused on understanding the varied experiences of different populations of students and identifying opportunities for tailoring efforts to meet their specific needs. Student safety is of the highest importance, and we will continue to implement best practices in sexual violence prevention to work toward a decrease in the incidence of sexual violence.

Some new initiatives this year include:

- In January 2024, Northeastern launched the Sexual Harm and Accountability PsychoEducation (SHAPE) Program, a research-informed education program designed for college students who have engaged in and/or been accused of unhealthy or harmful sexual behavior. Students in the program learn and build skills for developing healthy consensual future interactions and relationships. Learn more about the program <u>here</u>.
- For the past year, we have been working to improve compliance with incoming students completing Northeastern's required online sexual violence prevention training. Moving forward, students who do not complete the program will be issued a block within their student hub.

- Given concerns arising within student groups in the last year, Northeastern developed a new required online course for student leaders on how to prevent and respond to sexual violence in student groups.
- Northeastern is also developing new restorative justice options.

Northeastern Resources

- The <u>Sexual Violence Resource Center</u> provides confidential, trauma-informed support services to Northeastern students who have experienced any form of sexual violence. Students can request services by filling out this <u>form</u>. The "<u>You are</u> <u>Not Alone</u>" <u>Guides</u> provide in-depth information about a range of options and resources for survivors.
- The <u>Office for University Equity and Compliance</u> (OUEC) is charged with investigating and responding to allegations of sexual misconduct. Reports can be submitted online through the <u>Discrimination Complaint Form</u>.
- <u>Community Consultation</u> services serve Northeastern students, faculty, or staff looking for information on responding to disclosures of sexual violence, supporting others, and/or discussing prevention strategies.
- Find@Northeastern provides students with a variety of mental health resources. Full-time degree-seeking students across the Global University System can connect to confidential 24/7 urgent mental health support, unlimited free counseling sessions, and access to Headspace. Additionally, all Northeastern students can access a moderated peer-to-peer platform through Togetherall.
- <u>Spectrum Life</u>, available to Northeastern London students, includes a 24/7 helpline that connects students with a psychotherapist for in-the-moment support.
- <u>Confidential Resource Advising</u> Services provide restorative-informed assistance for Northeastern students who have been accused of any form of sexual violence. Students can request services by filling out this <u>form</u>.

Sexual Assault Awareness Month & Call to Action

Of students who endorsed experiencing sexual harm who chose to tell someone about their experiences, 90% spoke with a close friend. A positive, compassionate response to a disclosure can help a survivor feel safe and supported. It also increases the likelihood that they will seek out other resources or support in the future, if they want to. One action step you can take during Sexual Assault Awareness Month is to be trained on how to respond to disclosures of sexual violence via <u>OPEN's asynchronous RESPOND module</u>.

- took advantage of you when you were too drunk, high, or out of it to understand what was going on.
- threatened to end your relationship, spread lies about you, or verbally pressured you after you already said no.
- threatened to harm you physically or used physical force.
- otherwise failed to obtain your consent.
